

#### **Facilities**

Programs are housed at the May Center in Mount Morris and the Career and Technical Center in Batavia. These facilities enable students to receive a variety of experiences.

#### **Secondary Programs**

Staff work with personnel from the component school districts to assist each student in choosing a career path for which he or she is suited. When this career path has been selected, the student is enrolled in an appropriate program. All of our programs are oriented toward the practical world of work experience designed to teach students appropriate employment skills. Programs provide the background needed for successful transition to post-secondary education or employment.

Students attending this program have management and learning needs that interfere with academic progress. A teacher and one paraprofessional are assigned to each student grouping of 12 students.

### **Work Experience Programs**

Work Experience programs provide students with disabilities a combination of work and education that may lead to full-time employment. The programs offer students a continuum of support services needed to transition from school to work. Students receive assistance in developing the necessary skills and behaviors needed for successful employment and to help them become contributing members of society. Students are evaluated and instructed in "workplace" basics." This is a coordinated effort including the student, Coordinator of Work Experience, classroom teacher, parents, employer, CSE personnel, and possibly outside agencies when appropriate. Topics of instruction are: job attitudes and habits, employee/employer relationships, job and skill development, daily living skills including math and reading skills required to support successful employment.. Training sites may include: the BOCES career and technical centers, ARC facilities, community employment sites and/or classroom situations. The employer is contacted regularly to maintain a supportive work environment that encourages job and skill development. Continuous communication and observation reinforces appropriate work behaviors and attitudes, and assists the student in progressive skill development.

Work Experience Programs are provided on a continuum.

This service provides support in the workplace for students who need structured, direct support to learn employment skills. The job coach provides students with job specific supports, task analysis, task sequencing, task supports, quality control, efficiency, productivity and evaluation. The goal is to assist students with the development of independent entry level employment skills, some students may require continued supports in the postsecondary arena.

#### Types of Services Provided:

The job coach will promote full community access; secure employment opportunities; complete a task analysis of job; train student; improve student/ employer relationship; visit to worksite; evaluate job habits and attitude; report to teacher, parent/ guardian, employer, Work Experience Coordinator and CSE.

### Work Experience Skills Training (WEST)

Advanced Transition program for students age 18-21 who demonstrate the skills to be independent in a workplace and learn work-based skills under the direct supervision of an employer. Students are placed in a minimum of 4 work-based internships about 2-3 days per week, on the opposite days of the week students will work with staff to reinforce advanced work readiness and job

Advanced Transition program for students age 18-21 who demonstrate entry level employment skills, are ready for competitive employment, and will benefit from a supervised work-based experience to develop employment skills to sustain employment. Students will work in a paid employment community based worksite 2-3 days per week. The opposite days of the week students will attend class to reinforce job keeping skills and prepare for post secondary employment. This is a supervised paid work experience program that is supervised by a Work Experience Coordinator.

### Types of Services Provided:

Transitional services; expanded vocational assessment services; career preparation services; IEP development; classroom instruction to promote the development of workplace skills and competencies, attributes of successful employment, health and safety on the job, and applied academic and occupational skills. These experiences are paid and are supported by a classroom teacher, Work Experience Coordinator and worksite supervisor.

Students ages 14-16 develop a foundation for entry level employment and transition planning. The Practical Assessment Exploration System (PAES) is the focus of this program and students participate in the Lab 3-5 days per week for consistency and skill development. The classroom is a simulated work setting to evaluate competitive work potential and interest level, while simultaneously exploring various jobs, using real tools, and developing proper work behaviors. Students learn work skills and explore the work world. Students demonstrate appropriate work behaviors and communication skills while data is collected to develop a comprehensive evaluation of student performance and employment potential. School-based training in a variety of settings and an intensive work readiness curriculum combine to provide an excellent pre-employment vocational training for students.

These second-year students receive more specific instruction to prepare for entry level employment; school-based training, work readiness curriculum and begin to explore careers through work-based experience and exploration. Recommended prerequisite: Transition I. Career cluster areas may include; maintenance, grocery, retail, food service industry, hospitality and grounds keeping.

Students learn all aspects of a commercial kitchen; prep, cooking, sanitation, dishwashing, production, customer service as well as work readiness skills in preparation for entry level employment in food service or other area.

Related services; transitional services; job shadowing in the community; vocational training; basic math skills; IEP development and job training.

# LIVES (Learning Independence, Vocational and Educational Skills) COSER: 201.045

The LIVES program is a collaboration between the Genesee Valley BOCES and the State University of New York college at Geneseo (SUNY Geneseo) to provide a college based experience for students ages 18-21 with intellectual and/or developmental disabilities.

The overarching goal of the LIVES program is to promote self-determination, self-advocacy, independence and citizenship as students prepare for employment and postsecondary success. Students will participate in applied academics and work-based learning and have the opportunity to audit college classes in a full-day program. There is an application process for this program.

This service includes identification, diagnosis, and on-going evaluation and monitoring of students with speech and language disorders that interfere with communication and educational development. The speech therapist develops an individualized program to help each child achieve and maintain competencies in communication. Evaluations are available and services are provided to students in small groups, individually and/or within classroom settings.

### Types of Services Provided:

Evaluation; individual therapy; group therapy; consultation; augmentative/ assistive communication; oral motor; phonological processing and articulation therapy.

Occupational Therapy is concerned with the student's upper extremity functioning (including fine motor skills as cutting, coloring, pre-writing, manipulation skills and strengthening), perceptual functioning (including eye/hand coordination, letter and design copying, visual tracking), sensory integrative functioning (including postural control,

reflex integration and coordination

of parts of the body together and as separate units), and functioning in activities of daily living (including dressing, eating and other self-care areas) as they relate to the student's education program.

Occupational Therapy Services are designed to achieve functional outcomes that maximize the independence and the maintenance of health for students who are limited by a physical injury or illness, a cognitive impairment, a psychosocial dysfunction, a mental illness, a developmental or learning disability, or an adverse environmental condition within the context of the educational setting.

Evaluations are available and services are provided to students in small groups, individually, and/pr within classroom settings.

### Physical Therapy

This service addresses children's gross motor delays and their educational implications for learning. Physical therapy focuses on enhancing stable postures and efficient movement to help lay the foundation for higher learning. In addition to helping children acquire specific developmental milestones, therapy also focuses on improving muscle strength and control, functional mobility, endurance, range of motion, balance, coordination, body awareness, sensory processing, motor planning, daily living skills and the ability of children to ensure their student role in the educational environment.

Evaluations are available and services are provided to students in small groups, individually, and/pr within classroom settings.

Cost Determination: Per session or rate based on district participation in itinerant services

#### **Vision Services**

Vision services address a student's effective use of eyesight and is available for legally blind children or those who have a loss of functional vision ability in grades K - 12. New York State certified vision teachers teach students efficient use of their residual vision and develop alternate means of reading writing and other critical performance tasks. Evaluations are available and services are provided as direct or consult service.

#### **Types of Services Provided:**

Evaluation; individual sessions; group sessions; consultation; orientation training; mobility training; team teaching.

Service is delivered as direct or consult service.

The 6:1:1 program is designed to provide a small class size for students whose management needs are determined to be highly intensive and require individualized attention and intervention. This program offers an individualized instructional plan based on student need. Class size is a maximum of six students with a special education teacher and a paraprofessional. This option is available K-12 at multiple locations.

### Types of Services Provided:

Academic programs, related services, psychological and psychiatric consultation, family counseling, prevocational education, daily living skills, support services, community experience, physician services.

### 6:1+1 Intensive Therapeutic Program (ITP) COSER: 205.021

The 6:1:1 ITP program is designed to provide a small class size for students whose management needs are determined to be highly intensive and require additional behavioral and mental health supports. Class size is a maximum of six students with a special education teacher and a paraprofessional. Program supports include, but are not limited to, crisis intervention, social worker, and psychiatric evaluations and consultations.

### Types of Services Provided:



Under Level II, the management functions associated with operating a food service program are completed at the regional level by qualified staff. Local district cook managers become GV BOCES employees and also complete tasks for more than one district.

Optionally, schools may choose to participate in Level III, wherein all local district cafeteria employees become GV BOCES staff and all management functions are assumed by GV BOCES. The goal of the program is to balance the food service budget in each participating district; therefore, participation costs will vary from district to district, based on need and level of participation.

Districts are required to participate sequentially before opting to participate in the next level of the service.

### Health, Safety & Risk Management COSER: 615

This service provides assistance to local districts regarding the requirements, interpretations and applications of the various state and federal laws related to health and safety. This assistance includes on-site and online training, inspections, policy/plan

formation, document maintenance and other related activities. The regulations which require ongoing attention include:

- The NYS Right-to-Know Law and Federal Hazard Communication Standards (chemical safety)
- NYS DEC, DOT and federal EPA toxic waste laws
- NYS Lead Sampling in School Water
- NYS Uniform Fire Prevention and Building Code (fire inspections)
- NYS and EPA bulk petroleum storage regulations
- NYS Health Department swimming pool regulations
- OSHA requirements for respiratory protection programs and medical surveillance
- NYS Labor Department (PESH) safety standards
- State and federal asbestos regulations (including AHERA inspections and documentation)
- NYS Emergency Preparedness Planning requirements (including Project SAVE and Homeland Security)
- Rapid Responder emergency response and notification online service
- NYS Annual Inspection requirements
- Federal lead and radon testing recommendations
- Indoor air quality standards (including sampling & analysis)
- NYS Public School Building Safety Codes (including RESCUE)
- NYS pesticide regulations
- NYS Cardiac AED (defibrillator) regulations
- Regional informational meetings are conducted approximately three times per year, at or near each of the BOCES satellite office locations. The purpose of these meetings is to:
- Provide up to date information on changes in the various regulations
- Offer solutions for compliance
- Discuss the potential for cooperative purchases of goods and services to minimize costs

The Health & Safety Specialist attempts to keep all appropriate staff informed through newsletters and presentations at Superintendents, Business Managers, Building & Grounds and Transportation group meetings.

A staff of six Health & Safety Specialists provide continuous on-site assistance to participating districts in the form of inspections, consultations, staff training and records review. Currently, 66 school districts and four BOCES organizations benefit from the Health, Safety & Risk Management Service.

Cost Determination: Base service costs are determined by adding a charge per square foot to a standard base fee, in order to adjust for the variation in district sizes. Rapid Responder and Indoor Air Quality monitoring portals are available at additional per site annual fees. AED/CPR trainings are also available at additional costs based on levels of need.

### Cooperative Bidding Coordination COSER: 616

This program is designed to assist local school districts and BOCES in realizing savings that come from the power of purchasing on a cooperative basis. The coordinator meets with business officials, food service managers, superintendents of buildings and grounds, and other administrators from participating districts as part of the process of developing standard specifications for items which are needed.

The coordinator prepares proposals, inputs bid data information into the WinCap program on the computer, requests samples as needed, arranges for legal advertisements, solicits a broad range of vendors, coordinates the decision-making process and arranges for delivery.

Items bid include bread, milk, ice cream, groceries, food service supplies, custodial supplies, paper, fuel, athletic/ physical education supplies and refuse collection. The list can be expanded at districts' requests to include other food products, office machines, etc.

### **Employee Assistance Program**

The Employee Assistance Program is a professional assessment and referral service that helps employees and their families deal with any of a variety of personal problems, which may adversely affect their job performance and personal well-being. Both the employee and the employer acknowledge that many of these problems can be treated, particularly in the early stages, before an employee's job security is seriously threatened. Besides being confidential, the program is voluntary--it is designed to allow the employee or family to seek help on their own. The EAP coordinator will also follow up with employees and/or treatment resources to determine whether employees are receiving appropriate and effective services. This requires ongoing identification and evaluation of community, public and private agencies and programs which can provide services needed by the employees. The coordinator will also provide the necessary assistance to the employee and/ or employer in readjusting to a productive work relationship.

The EAP coordinator provides information, training and orientation to employees and supervisors regarding the EAP, and sponsors both wellness activities and educational workshops for participating schools. Finally, the EAP provides supervisors with consultation and support with regard to working with troubled employees and initiating referrals to the EAP.

# Absence Management for Employees and Substitutes (formerly AESOP) COSER: 619

This service can be used to report all time and attendance for all employees groups. Absences

that require approval can be electronically approved (paperless). In addition, this service is designed to assist districts in the assignment of substitute employees (teachers, teacher aides, teacher assistants, clerical, bus drivers, maintenance, food service). Employees and substitutes can use the phone and/or a web portal to report absences and/or to review available positions. Substitutes are secured based on each district's approved list. The Absence Management System is web-based, has many reports available, can be used for time and attendance purposes and can be integrated with WinCap, nVision, or Infinite Vision.

Cost Determination: Based on employee count and optional integration with Finance Manager, nVision, or Infinite Vision. All new districts to service must pay a one-time set-up fee.

The cost of the books is not aided.

Cost Determination: Based on usage BOCES Aid: Expenses associated with coordination are aidable, cost of books is not BOCES aidable

### **Energy Management**

The Energy Management service provides broad assistance and guidance to districts in areas related to the efficient use and design of electric, gas, and water systems; as well as related utilities.

Specific areas of assistance may include:

- Software based utility bill auditing
- Utility usage monitoring with unusual usage (spike) reports and load shedding assistance
- Annual boiler efficiency inspections
- Annual building infrared/thermal loss survey and report
- Identification and coordination with NYSERDA energy management funding
- Identification and coordination with NYSED Energy Project Funds
- Annual inspection and "continuous commissioning" of HVAC systems
- Assistance with utility (gas/electric) transportation group purchasing
- Waste stream management (reduction of disposal costs in paper, plastic, food, etc.)
- Water usage management (both usage reduction and discharge reduction)

Cost Determination: Costs are determined by adding to a base fee, a charge per square foot, in order to adjust for the variation in district sizes.

### Records Management (Electronic Document Scanning and Microfilm Scanning)

Staff will assist in the identification of records appropriate for scanning, prepare records, and index and scan records for long-term electronic storage. Staff will also verify inclusion of all documents scanned. Once district records are scanned, security and storage problems are

reduced and accessibility is enhanced. Staff will serve as consultants to the districts with regard to policies and procedures surrounding records management, retention, storage and disposition. The Genesee Valley BOCES and EduTech will maintain the security and confidentiality of all records housed for the purposes of scanning and permanent storage. Staff will perform retrievals of documents, with or without redaction, upon request with proper authorization.

New: The Records Management Department can scan and index records that are currently on microfilm for faster retrievals upon request.

Cost Determination: Base Fee plus per district by usage, storage quota and time.

The health care plan gives districts an option for the purchase of health insurance for employees and retirees. The coordination provides linkages between participating school districts, the Healthcare Board, the claims administrator, and the plan consultant. The executive director facilitates plan development, benefit identification, purchase of stop loss insurance, compliance with audit and state regulations, and provisions for claims administration.

Cost Determination: Per participant.

#### Flexible Benefits Plan

Flexible Benefits Plans are a proven solution for managing benefit costs and increasing employee satisfaction. Flexible benefits are vehicles that an employer can utilize to reduce taxes for both employers and employees. This service will assist the districts with the design, implementation and administration of both Pre-Tax Premium Plans and Flexible Spending Accounts.

### Pre-Tax Premium Plan

Employee contributions for group insurance premiums can be deducted before taxes are calculated. As a result, taxable earnings are reduced so employees pay less tax on earnings and receive more take-home pay.

### Flexible Spending Accounts

Expenses for non-insured items such as child care or medical bills can be paid from pre-tax dollars an employee sets aside in a Flexible Spending Account (FSA). Contributions, based on anticipated expenses, are allocated before taxes are calculated.

The Flexible Benefits Office will assist the districts in identifying the plan design that best achieves employer and employee objectives. Implementation and administration of the plan will include:

- Employee Communication: a) Group employee presentations; b) Individual counseling and enrollment sessions; c) Direct response to employee questions
- 2. Maintenance of Participant and District Records
- 3. Processing of employee Flexible Spending Account claims
- 4. Plan Compliance: a) Perform non-discrimination testing
- 5. Maintenance of an electronic module which allows employees to access their accounts online.

### **Self-Funded Workers Compensation**

This self-funded workers' compensation plan provides districts an option for the purchase of workers compensation insurance for employees. The Genesee-Livingston-Steuben-Wyoming Workers' Compensation Plan has been in place since June 1992. Coordination provides linkages between participating school districts, the Board of Directors, the claims administrator and the plan consultant. The cost of this service includes annual auditing fees, plan consultant, and plan treasurer's fees.

Cost Determination: Per district based on annual workers' compensation rate.

BOCES Aid: Program generates BOCES aid.

### **Health Reimbursement Accounts**

Health Reimbursement Accounts (HRAs) are employer-funded group health plans from which employees are reimbursed tax-free for qualified medical expenses up to a fixed dollar amount per year. Unused amounts may be rolled over to be used in subsequent years. The employer funds and owns the account. This service will assist the districts with the design, implementation and administration of pre-tax Health Reimbursement Accounts. Administration includes employee communication, maintenance of records, claims adjudication and plan compliance. Health Reimbursement Accounts are a proven solution for managing benefit costs and increasing employee satisfaction.

Cost Determination: Planning and Design per district; Claims processing flat fee, per employee. BOCES Aid: Program generates BOCES aid.

## **Special Programs**

### **Adult Educational Services**

Committed to the concept that learning is a lifelong process, Genesee Valley BOCES Adult Educational Services defines its mission as providing easily accessible programming for adults and their families. Among the many services provided are: career counseling, high school equivalency, job training, leisure learning and skills enhancement. Adult Educational Services also fosters linkages with local businesses in order to develop new programs in response to changes in work force needs.

### Inter-Agency Partnership

The initiative was developed on the state level in anticipation of the Welfare Reform JOBS Act. The goal is to move people from public assistance into the job market by providing opportunities for education and for career and technical training. As part of this initiative, the Genesee Valley BOCES offers such components as counseling, assessment and support services that address issues confronting adults as they pursue their educational goals.

#### Assessment/Remediation

Counseling, informational interviews, and structured assessment devices such as inventories and tests assist individuals in their career planning process. Assessment activities help individuals identify their interests, values, and academic skills to provide a frame of reference in which to make career decisions. Remediation is available to adult students who require additional academic assistance. Tutorial in nature, remediation, combined with various assessment tools, is designed to address the individual's weakness as prescribed in an educational plan.

High School Equivalency (HSE) • Local districts assign BOCES the responsibility to prepare adults for the High School Equivalency Examination. Academic preparation includes: English, essay development, science, math, social studies, literature and the arts. The new High School Equivalency Exams went into effect on January 1, 2015. Options for HSE preparation are:

 High School Equivalency and Adult Basic Education offered at: Batavia, Dansville, and Leicester. TASC and ABE instruction is also given at Genesee County Jail, Livingston County

- Jail and the Wyoming County Jail. Academic counseling, career exploration, work placement and assistance with vocational and post-secondary placement are also available for TASC students.
- 2. Home-study (GRASP) designed for students over 21 who cannot attend class because of barriers: i.e. lack of transportation, lack of child care, etc. Participants are screened and tested and an educational plan is devised. Two week assignment packets are sent to students with telephone contact encouraTASC. Students may return packets via assigned drop off points, local schools or direct mail. Telephone tutoring is utilized to maintain student motivation and direction. The program is also available online.
- 3. A partnership program with Genesee Community College provides TASC students the opportunity for study on a college campus.
- 4. The Genesee Valley BOCES is an official TASC testing site. Testing is administered several times each year. All students involved in our literacy programs will now be able to test locally at either our Batavia or Mount Morris sites.

English for Speakers of Other Languages (ESOL) • This program is designed to promote English fluency for the foreign speaking student/adult. Emphasis of instruction focuses on: reading and comprehension, communication with the written word, math skill development and familiarization with American culture. The program seeks to create independent individuals who can effectively interact in social and occupational situations. Classes are offered at the GV BOCES campuses in Mount Morris and in Batavia.

Adult Job Training • Job training classes teach specific career & technical skills. Programs such as CDL Class A & B Truck Driver Preparation, Certified Nurse Aide, Medical Billing Specialist, and Medical Office Skills consist entirely of adult learners and are designed specifically around their needs. Adults are also allowed to enroll in the high school career and technical courses depending upon space availability. As a component of these programs, counselors provide assistance with job search techniques and resumés.

#### Adult Services cont.

Case Management • A support system to help adult learners achieve their academic and career goals based upon the concept of looking at the person as a whole addressing not just the specific educational goals but also the barriers such as transportation or child care needs. Prospective students are assessed to help identify goals, educational plans are developed, and on-going counseling and advocacy are provided to assist in the achievement of career and/or academic objectives.

Program for Incarcerated Youth • Providing educational services to youths between the ages of 16 and 21 who are in the Genesee, Livingston and Wyoming County Jails. Educational programs consist of high school equivalency, adult basic education, life skills, and vocational and academic counseling. As mandated by law, the classes meet five days per week for three hours per day following the 180 day New York State Regents calendar. Instruction is also provided to adults over age 21 who do not have a high school diploma.

Employer Specific Training • The office of Adult Educational Services provides training services to local businesses and industry. Programs are flexible and cater to the specific needs of a company. Both intensive job training as well as brief refresher courses are offered in a variety of skill areas. Office skills include computer literacy, word processing, bookkeeping and business math. Vocational skills are taught in various production fields such as welding, carpentry, electricity, machine tool operation and computer aided design. Some classes, such as truck driver and nurse aide, prepare the learners to obtain licensure. Applied technical training results in a more effective and dynamic work force. These business assist programs also create an opportunity for twoway communication between the Genesee Valley BOCES and local businesses.

Continuing Education • Brief non-credit vocational and interest courses. Some of the classes are sequential, leading to a concentration in a particular area (e.g. computer software, electricity or business). Others are designed to be completed within a single course with classes meeting one

to two times a week for two to 12 weeks (e.g. sewing, sign language). Training and instruction either required or encouraTASC by the State, such as Child Abuse Recognition & Reporting, Defensive Driving and the five hour Prelicensing course are offered throughout the year. Classes are determined by public interest, appropriateness and feasibility. For these reasons offerings can change from session to session.

Transitional Services for Incarcerated Populations

A part-time Human Resource Development
Counselor provides assessment, counseling, career planning, case management, referral, advocacy, job-development, and follow-up to inmates of the Genesee, Livingston and Wyoming County jails.

Internship • Job-readiness activities which enable our students to initiate a successful job search are integrated into the classroom experience. An internship is a vital component of our career and technical and literacy programs. It allows our students the opportunity to become familiar with their chosen field while giving them actual work experience. Students are also involved in a series of workshops focusing on topics such as developing a resumé, writing cover letters, and successful interview techniques. Assistance with career exploration and planning is also available.

New York State Apprenticeship Program • The Adult Education Office serves as the local education agency for the Department of Labor in order to provide apprenticeship training. The Lead Coordinator is responsible for reviewing transcripts of apprentices and working collaboratively with area industries and unions.

Practical Nursing Program • A State Accredited Professional Practical Nursing Program approved by the New York State Board of Nursing. Upon completion the student is eligible to take the National League for Nursing Licensing Examination for Practical Nurses (NCLEX-PN) Nursing is a profession that offers many career opportunities. Licensed Practical Nurses are hired in a variety of

health care facilities and private practices.

The is a 1200-clock hour 12-month program. Classes are offered at both the Batavia and Mount Morris Campuses. There is also a satellite class site in Rochester.

Nursing Assistant Program for Adult Students
• Approved by the New York State Education
Department this program is considered a pathway
into the health careers field. Upon completion
students are eligible to sit for the Nursing Assistant
certification exam. The certification is now required
by all nursing homes to be employed as a Nursing
Assistant.

The is a 140-hour clock 10-12-week program, which includes testing time. We are approved to test on both the Batavia and Mount Morris Campuses.

Certified Nursing Assistant Refresher Course • This course is designed for those students who have completed a Nursing Assistant program and their certification has expired or individuals certified outside of New York state. The course consists of two 4-hour classes and an 8-hour testing day.

### **School Library System**

The Genesee-Livingston-Steuben-Wyoming School Library System has served area students and professionals since 1978. The mission of the School Library System is to promote interaction, cooperation and growth among the member school libraries, the School Library System and the State Education Department. The five main goals of the School Library System are:

- To oversee and facilitate interlibrary loan between member school district libraries
- To develop a combined union catalog of member library collections
- To disseminate current professional information to school library media specialists.

- To offer continuing education for member school library media specialists
- To provide leadership and development in the area of library automation and information technologies for the members of the School Library System

The School Library System accomplishes its goals through the School Library System Council and a group of Communications Coordinators, comprised of library representatives from each school district, administrative representatives, and representatives from regional research and public library systems. In addition, the School Library System directs several subcommittees such as the Cooperative Collection Development, Staff Development, and the Electronic Database committees. Council/group of Communications Coordinators are responsible for the development of policies and procedures which directly affect the quality of library service in member building libraries.

The School Library System is comprised of school library media centers in the Genesee Valley BOCES district. Other services provided by the School Library System include database searches, a storytelling festival, a curriculum aligned game library, a cooperative collection development program, continuing education programs for library media specialists, development of an extensive professional collection, and various other programs designed to give special services to the component schools.

Funding for the School Library System is provided under statutory state regulations through Section 90.18, Chapter 348 of the Laws of 1984. The School Library System receives no local monies for its operation.

The Student Support Services (SSS) Center provides assistance to school communities with developing, enhancing and sustaining supportive, safe and healthy learning environments in order to increase academic achievement and student success. Support includes technical assistance and professional learning to advance the implementation of systemic research-based approaches with policies, practices and environmental changes that exemplify mission, vision and goals.


One area of support is building the capacity of schools in the region to effectively implement the Dignity for All Students Act. The SSS Center is a New York State Education Department (NYSED) approved provider for the 6-hour Harassment, Bullying and Discrimination in Schools: Prevention and Intervention Certification Training – also called DASA Certification Course. The SSS Center also provides additional DASA training and support specifically for administrators, staff/employees and school district Dignity Act Coordinators. Additionally, the Center is a NYSED approved provider of the Child Abuse Identification and Reporting (CAIR) Certification Course and the NYSED School Violence Prevention and Intervention (SAVE) Certification Course. Certification Courses are offered online.

The SSS Center also supports schools and the communities they serve with aligning, coordinating, and integrating comprehensive health and wellness related policies, programs and practices to create equitable, engaging and healthy environments. This includes facilitation and implementation of the Whole School, Whole Community, Whole Child Model (WSSC) Model collaboratively developed by the Centers for Disease Control and the Association for Supervision and Curriculum Development. Areas of emphasis include physical activity, nutrition, health education, school counseling, social and emotional climate, employee wellness, family and community engagement.

# **Cross Contracting with Other BOCES**

Cross contracts must be completed whenever another BOCES is providing services or programs for a Genesee Valley BOCES component school district. Cross contracts are necessary to ensure the contracting district receives the aid available under the specific COSER. The following procedure must be followed to establish a cross contract:

- 1. The District Superintendent of the Genesee Valley BOCES must receive a written request to participate in a specific service from the local superintendent.
- 2. Genesee Valley BOCES forwards the providing BOCES District Superintendent correspondence which initiates the local school district request.
- 3. The local school district receives a copy of the correspondence sent to the providing BOCES (confirms request).
- 4. The cost of the program/service provided by the other BOCES will be included on the regular invoice sent by the Genesee Valley BOCES, and the charge in turn must be paid to the Genesee Valley BOCES as part of the monthly bill.
- 5. NOTE: All cross contracts require a new participation request from the local district each year.
- 6. Examples of previously requested cross-contracts:
  - Special Education, Monroe One BOCES
  - Elementary Science Kits, Monroe 2-Orleans BOCES
  - Computer Services for Career Exploration, Wayne-Finger Lakes BOCES
  - Project Intervention, Monroe One BOCES

  - Administrative Computer Services, Wayne-Finger Lakes BOCES
  - Finance & Legislation, Erie 1 BOCES
  - State Aid Planning, Questar III BOCES


